Australian Securities and Investments Commission Corporations Act 2001 - Subsection 340(1) - Order

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this order under subsection 340(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This order is ASIC Instrument 24-0903.

Commencement

3. This order commences on the date it is signed.

Order

- 4. Genesis Care Pty Limited ACN 137 188 464 (*Genesis Care*), and its directors, do not have to comply with the following requirements in Part 2M.3 of the Act (continuing obligations) in relation to Genesis Care's financial year that ended on 30 June 2023 (*Relevant Financial Year*):
 - (a) the requirement to prepare a financial report and directors' report under paragraph 292(1)(c);
 - (b) the requirement to have the financial report audited and to obtain an auditor's report under subsection 301(1);
 - (c) the requirement to report to its members under section 314 within the time required by section 315;
 - (d) the requirement to send reports to a member in accordance with a request under subsection 316(1) within the time required by subsection 316(2);
 - (e) the requirement to lodge reports with ASIC under subsection 319(1) within the time required by subsection 319(3) as extended by the Genesis Care ASIC Extension Instruments;

to the extent that the non-compliance results from:

- (f) the preparation of a 'Special Purpose Combined Financial Report' for the Relevant Financial Year in lieu of a Part 2M.3 of the Act compliant financial report for the Relevant Financial Year;
- (g) the preparation of a 'Special Purpose Directors' Report' for the Relevant Financial Year in lieu of a Part 2M.3 of the Act compliant directors' report for the Relevant Financial Year;
- (h) the preparation of a 'Compilation Report' in relation to the 'Special Purpose Combined Financial Report' for the Relevant Financial Year in lieu of an auditor's

- report on a Part 2M.3 of the Act compliant financial report for the Relevant Financial Year;
- (i) sending the 'Special Purpose Combined Financial Report', 'Special Purpose Directors' Report' and 'Compilation Report' for the Relevant Financial Year to the Genesis Care's members in lieu of sending a Part 2M.3 of the Act compliant financial report, directors' report and auditor's report for the Relevant Financial Year to the Company's members; and
- (j) lodging the 'Special Purpose Combined Financial Report', 'Special Purpose Directors' Report' and 'Compilation Report' for the Relevant Financial Year with ASIC on or before 30 November 2024 in lieu of lodging a Part 2M.3 of the Act compliant financial report, directors' report and auditor's report for the Relevant Financial Year to the company's members.

Note: Genesis Care is required to lodge the Special Purpose Combined Financial Report, Special Purpose Directors Report and Compilation Report for the Relevant Financial Year with ASIC by 30 November 2024. See paragraph 9(b).

5. For the avoidance of doubt, the relief provided by section 4 of this instrument applies to any continuing obligations of Genesis Care in relation to the Relevant Financial Year, including by reason of any failure to comply with any conditions of relief within the required time frames under the Genesis Care ASIC Extension Instruments.

Note: A company that is required to do an act under Part 2M.3 of the Act within a particular period or before a particular time continues to be subject to an obligation to do the act even after the period has ended or that time has passed: section 1314 of the Act. Sections 4 and 5 of this instrument do not affect any liability that existed under Part 2M.3 of the Act and s1314 of the Act at any time before the date of this instrument.

- 6. Each Large Group Company, and their respective directors, do not have to comply with the following requirements of Part 2M.3 of the Act (continuing obligations) in relation to the Large Group Company's financial year ended 30 June 2023 (also *Relevant Financial Year*):
 - (a) the requirement to prepare a financial report and directors' report under paragraph 292(1)(c);
 - (b) the requirement to have the financial report audited and to obtain an auditor's report under subsection 301(1);
 - (c) the requirement to report to its members under section 314 within the time required by section 315;
 - (d) the requirement to send reports to a member in accordance with a request under subsection 316(1) within the time required by subsection 316(2); and
 - (e) the requirement to lodge the reports prepared or obtained under Division 1 of Part 2M.3 with ASIC under subsection 319(1) within the time required by subsection 319(3).
- 7. For the avoidance of doubt, the relief provided by section 6 of this instrument applies to any continuing obligations of each Large Group Company in relation to the Relevant Financial Year, including by reason of any failure to comply with any conditions of relief

within the required time frames under the Large Group Company ASIC Extension Instruments.

Note: A company that is required to do an act under Part 2M.3 of the Act within a particular period or before a particular time continues to be subject to an obligation to do the act even after the period has ended or that time has passed: section 1314 of the Act. Section 6 and 7 of this instrument do not affect any liability that existed under Part 2M.3 of the Act and s1314 of the Act at any time before the date of this instrument.

Where this instrument applies

- 8. This instrument applies where:
 - (a) Genesis Care and the Subsidiaries (collectively, the *Debtors*) commenced voluntary financial restructuring under Chapter 11 of the United States Bankruptcy Code by a voluntary petition filed in the Southern District of Texas on 1 June 2023 (*voluntary financial restructuring*);

Note: Court filings and information about the Chapter 11 Cases are available on a separate website (https://restructuring.ra.kroll.com/GenesisCare) administered by Genesis Care's claims agent, Kroll. Information is also available by calling +1 (833) 744-6948 (U.S./Canada Toll-Free), +61 (2) 9925 4385 (Australia), +44 (20) 45198440 (UK) and +1 (646) 440-4836 (International).

- (b) the Debtors completed the voluntary financial restructuring and emerged from Chapter 11 following the confirmation of the Debtors Chapter 11 Plan of Reorganisation by the U.S. Bankruptcy Court for the Southern District of Texas and satisfaction of necessary conditions on 16 February 2024;
- (c) pursuant to the voluntary financial restructuring Genesis Care sold or otherwise disposed of the Foreign Companies on or about 16 February 2024;
- (d) on completion of the voluntary financial restructuring, Genesis Care ceased to be in possession of the financial records of the Foreign Companies but has contractual rights of access to those financial records;

Note: Under s286 of the Act companies are required to keep written financial records that correctly record and explain its transactions and financial position and performance and would enable true and fair financial statements to be prepared and audited.

(e) ASIC had extended the time for compliance with Part 2M.3 of the Act by Genesis Care and the Large Group Companies for the Relevant Financial Year to 30 November 2024 subject to conditions;

- (f) The Closed Group Companies are parties to a deed of cross guarantee in ASIC Pro Forma (PF 24) dated 10 March 2020 (as varied by Revocation Deed under ASIC Pro Forma [PF 26] dated 7 November 2022, Deed of Variation dated 20 June 2018 and Assumption Deeds under ASIC Pro Forma [PF 27] dated 23 June 2020, 30 June 2022 and 28 June 2023 and as affected by Notices of Disposal under ASIC Pro Forma [PF25] dated 30 September 2022;
- (g) Genesis Care is 'Holding Entity' of the Closed Group Companies for the purposes of relief under ASIC Corporations (Wholly-owned Companies) Instrument 2016/785 or ASIC Class Order [CO 98/1418] for financial years ending on or before 30 June 2022;
- (h) The Closed Group Companies may have relied on relief under *ASIC Corporations* (Wholly-owned Companies) Instrument 2016/785 or ASIC Class Order [CO 98/1418] for financial years ending on or before 30 June 2022;
- (i) The combination in the 'Special Purpose Combined Financial Statements' does not meet the definition of a group as defined by AASB 10 *Consolidated Financial Statements* by reason of not consolidating results of the Non-Closed Group Companies and the Foreign Companies for the Relevant Financial Year;

Note: The investments in the Non-Closed Group Companies and the Foreign Companies are accounted for in the Special Purpose Combined Financial Statements at cost less any accumulated impairments: see note 16 to the Special Purpose Financial Statements

- (j) In all other respects, the 'Special Purpose Combined Financial Report' has been prepared in accordance with the recognition and measurement requirements of Australian Accounting Standards;
- (k) The Compilation Report has been prepared by a registered company auditor who is not the appointed auditor of Genesis Care or of the Closed Group Companies and Non-Closed Group Companies;
- (l) The Company submitted to ASIC, among other things, that that the administrative burden of compliance with Part 2M.3 of Act by Genesis Care and the Large Group Companies was out of all proportion to the value of the resultant disclosure to the Australian users of Genesis Care's reports and the Large Group Companies reports following completion of the voluntary restructuring; and
- (m) ASIC was persuaded, among other things, that the administrative burden of compliance with Part 2M.3 of Act by Gensis Care and the Large Group Companies was out of all proportion to the value of the resultant disclosures to the Australian users of Genesis Care's reports, or the user to of the Large Group Companies reports, following completion of the voluntary restructuring in Genesis Care's unique circumstances and that it was ultimately in the interests of Australian users of Genesis Care's reports to have the use of the Special Purpose Combined Financial Report and accompanying Special Purpose Directors' Report and Compilation Report for the Relevant Financial Year by 30 November 2024.

Note: See ASIC Regulatory Guide 43 *Financial reports and audit relief* generally and at paragraph RG 43.31. See also ASIC Regulatory Guide 174 Relief for externally administered bodies and registered schemes being wound up generally and at paragraphs RG 174.112 and RG 174.113.

Conditions

9. Genesis Care must:

- (a) ensure that the Special Purpose Combined Financial Report for the Relevant Financial Year contains an explanation of the relief provided by this instrument including the conditions specified in this section and in section 10 of this instrument;
- (b) lodge the Special Purpose Combined Financial Report, the Special Purpose Directors' Report and the Compilation Report for the Relevant Financial Year with ASIC under ASIC Form 388 by 30 November 2024;
- (c) arrange for a notice explaining the relief granted by this instrument, together with a copy of this instrument, to be published in a prominent place on the Genesis Care website under "News:" within 5 business days after the date of commencement of this instrument; and
- (d) have adequate arrangements in place to answer, within a reasonable period of time and without charge, any reasonable questions asked by a creditor of Genesis Care or a Large Group Company about:
 - (i) the voluntary financial restructuring;
 - (ii) the Large Group Company's deed of cross guarantee arrangements with Genesis Care:
 - (iii) the Special Purpose Combined Financial Report, the Special Purpose Directors' Report and the Compilation Report for the Relevant Financial Year; and
 - (iv) this instrument;

within 5 business days after the date of commencement of this instrument and until such time as is approved by ASIC to dispense with the arrangements;

and this instrument applies for so long as these conditions are met.

10. Each Large Group Company must:

- (a) arrange for a notice explaining the relief granted by this instrument to be published in a prominent place on the Genesis Care website under "News:" within 5 business days after the date of commencement of this instrument; and
- (b) have adequate arrangements in place to answer, within a reasonable period of time and without charge, any reasonable questions asked by a creditor of the Large Group Company about:
 - (i) the voluntary financial restructuring;
 - (ii) the Large Group Company's deed of cross guarantee arrangements with Genesis Care;

- (iii) the Special Purpose Combined Financial Report, the Special Purpose Directors' Report and the Compilation Report for the Relevant Financial Year; and
- (iv) this instrument;

within 5 business days after the date of commencement of this instrument and until such time as is approved by ASIC to dispense with the arrangements;

and this instrument applies for so long as these conditions are met.

Interpretation

11. In this instrument:

Closed Group Companies means the companies listed in Schedule B.

Compilation Report means the compilation report prepared by CIB Accountants and Advisers and dated 26 November 2024 in relation to the Special Purpose Combined Financial Report for the Relevant Financial Year.

Foreign Companies means the companies listed in Schedule D.

Genesis Care ASIC Extension Instruments means ASIC Instrument 23-0806 dated 31 October 2023 as amended by ASIC Instrument 24-0206 dated 18 March 2024, ASIC Instrument 24-0306 dated 29 April 2024, ASIC Instrument 24-0545 dated 28 June 2024, ASIC Instrument 24-0636 dated 31 July 2024, ASIC Instrument 24-0711 dated 28 August 2024, ASIC Instrument 24-0797 dated 30 September 2024 and ASIC Instrument 24-0847 dated 31 October 2024.

Large Group Company means any one of the companies listed in Schedule A.
